- Website usage behavior (pages visited, time spent, click behavior)

#### d. Marketing & Communications Data

- Preferences in receiving marketing communications
- Engagement with WhatsApp messages or emails sent via our Meta WhatsApp Business integration

### 2. How We Use Your Information

We use the information we collect to:

- Process your orders and deliver your purchases
- Improve our website, services, and customer experience
- Personalize your experience and tailor marketing content
- Communicate with you regarding your orders, inquiries, or feedback
- Send promotional messages, offers, and product updates via WhatsApp or email (only with your consent)
- Ensure website and data security
- Comply with applicable UAE laws and regulations

## 3. Sharing and Disclosure of Data

We do **not sell, trade, or rent** your personal data. However, we may share your information with:

- Payment gateways & logistics partners to facilitate order fulfillment
- **Service providers** like marketing platforms (e.g., Meta WhatsApp Business API) under strict confidentiality agreements
- Government or regulatory authorities, if legally required under UAE law
- Technology partners who assist us in operating the website securely and efficiently

All third parties are obligated to protect your information and use it only for specified services.

## 4. Data Security

We are committed to ensuring your personal data is secure. To prevent unauthorized access, disclosure, or misuse, we use:

- SSL encryption for data transmission
- Secure firewalls and access controls
- Regular security audits and system monitoring
